I.

### **Who is responsible for the processing of personal data?**

The administrator of the personal data collected through this website and responsible for its processing is JASOL S.A. with its registered office in Katowice, 13 Uniwersytecka Street.

### **What data are processed?**

You can access our Website without providing personal information (such as name, postal address, e-mail address). However, also in this case, in order to enable you to use the Website, we may obtain certain information, including that containing personal data. In addition, we also use tools on this Website to enable us to better tailor the Website to you and to determine your search preferences, including information that allows us to profile you.

**Login Data:** When you visit our Website, the server automatically stores the domain name or IP address of your computer (usually your ISP's computer), including the date, time and duration of your visit, the sub-pages / URLs you visit, and information about the browsers you use to view our pages.

**Cookies:** Like many other operators, we use cookies to make our site as user-friendly as possible. Cookies are small text files stored in your browser. They help to identify certain preferences of visitors to our Site during their visit and to tailor the content accordingly. Most of the cookies we use are temporary files. They are automatically deleted when your visit to our site ends. However, we also use permanent cookies. They are used to improve the quality of use of the Site, and may also be used for analytical and marketing purposes. Below we have listed the most important cookies we collect.

**Temporary cookies (session cookies)** - installed on your device for the duration of the session, they are deleted when you close your browser.

**Permanent cookies (persistent cookies)** - are not deleted when the browser is closed, remain on the device for a specified period (depending on the browser).

Proprietary cookies (first-party cookies) - placed by us in order to enable proper operation of the site, to provide proper functionality (e.g. proper display of pages, bookmarks), configuration, verification of authenticity and reliability of service operation.

Third-party cookies - we may use external tools, provided by third parties, in particular for statistical purposes (e.g. as part of our use of Google Analytics).

Installed cookies do not cause configuration changes on your device. If you would like to learn more about how cookies work, we encourage you to visit sites such as:

The use of cookies for data collection, including accessing data stored on your device, is with your prior consent. However, consent does not apply if we use cookies to provide a telecommunications service (data transmission to display content on a website, in an application).

In most web browsers, acceptance of cookies is set by default, while you can always change your settings and specify the conditions for storing and accessing your data, so that cookies are blocked or you are informed that they are sent to your devices. Proper configuration of your browser settings also allows you to refuse acceptance of cookies. However, this may mean that you will not be able to use all features of the Website.

Analysis of the Website by Google Analytics: In order to continuously improve our Website, we use Google Analytics, a web data analysis tool of Google Inc, 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA ("Google"). Google Analytics uses cookies that are stored on your computer to analyze your use of the Site. The information generated by the cookies about your use of the Website is usually sent to a Google server in Europe (or a member state of the European Economic Area) to anonymize your IP address, making it impossible to directly link the address to you. Only after the IP address has been anonymized is this abbreviated IP address transferred to a Google server in the US and stored there. The full IP address may be sent directly to a Google server in the USA and only abbreviated there.

in exceptional cases. This Site uses Google Analytics with an extension for anonymous collection of IP addresses (so-called IP masking). Google will use the collected information on behalf of our company to evaluate your use of the Site, to create reports on Site activity and to provide other services related to the use of the Site. The IP address transmitted by your browser as part of Google Analytics is not combined with other Google data.

You may object to our collection of data using Google Analytics tools, in particular by selecting appropriate settings in your browser that restrict the collection of cookies.

You may opt out of using cookies by selecting the appropriate settings in your browser. However, it is worth bearing in mind that if you do so, you may not be able to take full advantage of all the features offered by our Site. #### **For what purpose and on what legal basis is your personal data processed?**

Personal data potentially contained in the login files and the advertising tools and cookies used may be processed to enable you to use our Website and to customize content, including marketing content, based on our legitimate interest (Article 6(1)(f) of the RODO) related to carrying out activities that enable you to use the Website in a comfortable manner and related to promoting our own products and services in connection with the profiling of Website users in order to issue appropriate advertising.

#### **Are you required to provide data?**

By visiting our site by automatic means your data is collected, in particular on the basis of cookies. The collection of data is necessary to enable you to use the site.

V.

#### **Who has access to your personal data?**

Your personal data may be accessed by entities authorized to do so under applicable laws, in particular inspection and law enforcement authorities as part of ongoing investigations. Your data is also collected by your Internet service provider, web hosts, and in the case of the use of the above-mentioned marketing tools, Google has access to the extent indicated above.

VI.

**Do we use automated decision-making?**

Yes, we may use profiling tools, in particular Google Analytics, as described above to provide personalized advertising in promoting our own products and services and analyzing website traffic.

VII.

**How long do we keep data?**

Generally, we keep personal data for as long as we are required to do so by law or have a legitimate interest in continuing to process the data, in which case we perform a balancing test to determine the primacy of our processing interests and your interest as a data subject. We aim to keep your personal data for the duration of your visit to the website.

VIII.

**What rights do data subjects have?**

Each person whose data we process on this website has rights to:

- request access to and obtain a copy of their personal data, Article 15 RODO;
- request the rectification of inaccurate personal data, Article 16 RODO;
- request deletion of personal data, Article 17 RODO; in case there is no legal contraindication to such deletion;
- request restriction of processing of personal data, Article 18 RODO;
- exercise your right to data portability, Article 20 RODO; if your data are processed on the basis of consent or contract;
- object to the processing of your personal data, art.21 RODO, for reasons related to your particular situation;
- exercise your right not to be subject to a decision that is based on profiling where it produces legal effects on you or materially affects you, the right to challenge that decision and express your position, art.21 RODO.

The above rights can be asserted, for example, by notifying us using the email address of the data protection officer [rodo@flukar.eu](mailto:rodo@flukar.eu). In the case of data collection by Google tools, we have indicated to you above how you can file your objection. In addition, you have the right to file a complaint regarding mishandling of your personal data with the competent supervisory authority, Article 77 of the RODO.
